### 4. NUMBER OF WORKS

To participate in 1<sup>st</sup> INTERNATIONAL FAIR OF PHOTOGRAPHY “BOR 2008” the authors apply with black & white and color works in digital form at FREE theme. Maximum number of works is four (4), dimensions 20x30 cm, 300 dpi and JPG format on a CD. The works accompanied by incorrectly filled application forms will not be taken into consideration. The works must be marked by ordinal numbers ordered in the same manner as in the application form. The works selected by the jury will be printed in 20x30 cm format and exhibited at the exhibition at the gallery of the Museum of “Mining and Metallurgy” in Bor. The printed photographs along with the received CDs will be permanently kept in the archives of the Museum of “Mining and Metallurgy” in Bor.

All author’s rights are reserved by the author.

### 5. PARTICIPATION FEE

Participation fee is 25 euros (30\$), for FSS members it is 800 dinars. The fee is to be sent either together with the CD or paid into dinar gyro account 170-4382-60 or into foreign currency account (the instruction for payment can be found at the last page). Also, participation fee can be paid by **VISA and MASTER CARD** card or by **PAYPAL** mechanism, in that case you can send your works by e-mail. All instructions at [www.photoclub202.com](http://www.photoclub202.com) . In that case you have to edit your photos in 20x30cm in 300 pixels/inch, and **compress them on 7**. Each author who sends photographs for the exhibition and pays participation fee will receive fully illustrated catalogue. The works of the authors who did not pay the fee would not be taken into consideration and the authors would not receive the catalogue.

**THE PRINTED CATALOGUE WILL INCLUDE ALL RECEIVED PHOTOGRAPHS.**

### 6. IDENTIFICATION

The folder of each photograph should include the following data:

Name of the author; name of the photograph in one of the official FIAP languages (or some other identification).

The number marking the work in the collection must match the number marking it in the application form.
